PHOTOGRAPH POLICY

REGISTRATION AND PERMISSION FORMS

WARNING CONCERNING COPYRIGHT RESTRICTIONS: The Copyright law of the United States (title 17, US Code) governs the making of photocopies or other reproductions of copyrighted materials.

Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproductions.
